FIRE DEPARTMENT

1. Activity Report – July 2020

Deputy Fire Chief Craig Proulx provided an overview of the report. Deputy Chief Proulx reported nine incidents in March; nine incidents in April; 14 incidents in May; 12 incidents in June; and 17 incidents in July. Deputy Chief Proulx highlighted the structure fires that occurred in April (Danny's Restaurant); May

(house and garage on Michael Crescent; deck and house on Spruce Street; and two houses on Riverstone Trail); and July (house on Jan Drive; and house on Limestone Trail struck by lightning). Deputy Chief Proulx reported fire fatalities have increased by 65% in Ontario in 2020 between January and May, compared to fire fatalities reported in 2019 for the same time period – there is some speculation that this increase could be associated with the COVID-19 pandemic, since people are home more often now compared to pre-pandemic. Deputy Chief Proulx also reported swift water rescue training was conducted in May and 16 personnel are now qualified to perform swift water rescues.

4. <u>ADMIN-17-2020 - COVID-19 Economic Recovery Act, 2020 (Bill 197) - Amendments to Section 238 of the Municipal Act, 2001</u>

Dawn Recoskie provided an overview of the report. Ms. Recoskie explained that Council adopted By-law 1338/20 on May 25, 2020 to amend Procedural By-law 550/09 to permit Council to meet electronically during a declared emergency under Section 4 or 7.0.1 of the *Emergency Management and Civil Protection Act*. The adoption of *Bill 197* has removed the authority for Council of the Corporation of the Town of Petawawa to meet electronically during a declared emergency, thus making By-law 1338/20 null and void. Should Council wish to participate in electronic meetings in the future; the Procedural By-law 550/09 will need to be amended as such. A draft by-law was provided for Council's consideration suggesting that Council would like to have the option of holding its meetings electronically should the COVID-19 pandemic continue long-term or should other extenuating circumstances occur where it would be advisable to meet electronically.
