4. <u>Municipal Emergency Control Group Update Regarding COVID-19 – Verbal Report</u>

Karen Cronier, Community Emergency Management Coordinator, and Daniel Scissons, CAO/Clerk, provided a verbal update to Council regarding COVID-19 and the actions that have been taken so far:

- The Town of Petawawa will continue to maintain essential services such as curbside garbage and recycling pick-up, routine road maintenance and landfill operations;
- The Municipal Office will remain open at this time; however, residents are encouraged to make payments online or via cheque utilizing the afterhours drop box;
- Residents are encouraged to practice social distancing and to avoid nonessential trips in the community; avoid visiting long-term care homes, retirement homes, hospices etc.; limit or consider cancelling group gatherings; consider having virtual meetings as opposed to in-person meetings;
- The Petawawa Civic Centre has been closed to the public for three weeks or until further notice; recreational programs such as the March Break camp and other events within the Civic Centre have been cancelled or postponed;

- The Petawawa Public Library has also been closed to the public until further notice; and
- Updates and other government website links regarding COVID-19 are available on the Town's website (www.petawawa.ca).

The Municipal Emergency Control Group will continue to meet as needed; the Federal and Provincial response to the COVID-19 pandemic is fluid and changing on a daily basis.
