# Public Meeting

1. <u>Zoning By-law Amendment (from "Rural (RU)" to "Residential One – Exception</u> (R1-E)" zones), Part of Lot 17 and 18, Concession 1, Barron Canyon Road

The Public Meeting was opened by the Mayor at 7:00 p.m. Melanie Scheer, Director of Planning and Development, advised that Notice of the Public Meeting had been provided as required under the *Planning Act*. A written submission was received from Enbridge Gas Inc. who had no concerns regarding the application. No other written submissions were received.

Ms. Scheer explained the purpose and effect of the amendment is to rezone the new lots being created by consent to Residential One Exception (R1-E) zones. The amendment is a condition of approval for consents B102/23(1)), B103/23(2), and B104/23(3). The effect of the amendment will be to permit residential uses on the lots in accordance with the R1 zone subject to the following additional provisions:

- Increasing the minimum front yard depth from 7.5 metres to 173 metres to provide the required minimum distance separation from a nearby livestock facility.
- Prohibiting the use of the existing outbuildings to house livestock.

• Reducing the minimum lot frontage on Barron Canyon Road from 30 metres to 20 metres.

Mayor Serviss asked to hear comments from the applicant. The applicant was not present to speak on the application.

Mayor Serviss asked to hear comments from members of the public. Wayne Bando asked if the applicant could consider installing a fence between the properties.

Ms. Scheer then explained the appeal process to those present.

Mayor Serviss declared the Public Meeting closed at 7:06 p.m.

2. <u>Zoning By-law Amendment (from "Rural (RU)" to "Residential One (R1)"), Part of</u> Lot 5, Concession 8, Rantz Road

The Public Meeting was opened by the Mayor at 7:06 p.m. Melanie Scheer, Director of Planning and Development, advised that Notice of the Public Meeting had been provided as required under the *Planning Act*. A written submission was received from Enbridge Gas Inc. who had no concerns regarding the application. No other written submission were received.

Ms. Scheer explained the purpose and effect of the amendment is to rezone new lots being created by consent from Rural (RU) to Residential One (R1). The effect of the amendment will be to permit residential uses on the lots in accordance with the R1 zone.

Mayor Serviss asked to hear comments from the applicant. The applicant chose not to come forward to speak on the application.

Mayor Serviss asked to hear comments from members of the public. No one from the public came forward to speak for or against the application.

That Council of the Corporation of the Town of Petawawa adopt the following motion:

**Whereas** trade between Ontario and the United States is vital to the economic prosperity of Petawawa and its businesses, industries, and workforce; and

Whereas the proposed tariffs on Canadian goods exported to the U.S. could negatively impact local businesses, industries, and municipalities, increasing costs and reducing economic opportunities; and

Whereas according to data from the Association of Municipalities of Ontario, across Ontario municipalities are expected to spend between \$250 and \$290 billion on infrastructure in the next 10 years; and

Whereas municipalities spend over \$22 billion annually procuring goods and services and are willing and eager to use this significant buying power to support the federal and provincial governments in protecting Ontario and Canada's economic well-being; and

Whereas municipalities play a key role in local economic development and procurement, and should have the ability to support local businesses while ensuring value for taxpayers; and

Whereas Ontario municipalities have traditionally treated trade partners equally and fairly in all procurements in accordance with our established international trade treaties; and

Whereas Canada's Prime Minister and Ontario's Premier have outlined several plans to combat the impact that the proposed tariffs would have on Ontario which focus on strengthening trade between Ontario and the U.S. while bringing jobs back home for workers on both sides of the border; and

Whereas the Canadian government has also outlined several ways to address the current relationship with the U.S. including establishing the Council on Canada-

U.S. relations to support the federal government as it negotiates with the U.S. on tariffs; and

Whereas trade between Ontario and the U.S. is very important to our residents and local economies, and requires all levels of government to work together in the best interest of those residents; and

Whereas many Ontario municipalities are passing resolutions calling for a united, cross-Canada approach to supporting buy-Canadian initiatives, and collaboration to remove barriers that prevent municipalities from giving preference to Canadian suppliers during procurement; and

Whereas the Eastern Ontario Wardens' Caucus (EOWC) has passed resolutions supporting the efforts of the Canadian and Ontario governments in their negotiations with the U.S. to address these trade barriers; and

**Therefore, be it resolved that** the Town of Petawawa supports other Ontario municipalities that have passed resolutions urging the Canadian and Ontario governments to take all necessary measures to protect Ontario's interests in trade negotiations and to ensure municipalities are included in a coordinated response;

And further that the Town of Petawawa supports efforts to remove barriers that limit municipalities' ability to prioritize Canadian suppliers in procurement while ensuring fair and transparent trade practices;

And further that the Town of Petawawa continues to support local businesses, industries, and workforce, through the efforts of the Economic Development department, including Shop Local and Buy Canadian campaign;

And further that this resolution be forwarded to the Eastern Ontario Wardens' Caucus, the County of Peterborough, the Federation of Canadian Municipalities, the Association of Municipalities of Ontario, the Rural Ontario Municipal Association, local municipalities of Renfrew County, and relevant federal and provincial representatives. **Carried**
