Call to Order

The Mayor called the meeting to order at 6:30 p.m.

Land Acknowledgement

Public Meeting

1. Zoning By-law Amendment (from General Industrial-Exception Five (GM-E5) to General Industrial-Exception Eight (GM-E8), Part of Lot 22, Concession 5, Water Tower Road

The Public Meeting was opened by the Mayor at 6:33 p.m. Karen Cronier, Director of Planning and Development, introduced the zoning by-law amendment application for rezoning the subject lands to permit a veterinary hospital and to permit the reduction in frontage from 30 metres to 24.9 metres. Ms. Cronier advised that the Notice of the Public Meeting had been provided as required under the *Planning Act*.

Mayor Serviss asked if any written comments have been received regarding the application. Ms. Cronier confirmed that one written submission was received from Enbridge Gas Inc., of whom had no concerns regarding the application.

Ms. Cronier briefly explained the purpose of the amendment is to rezone the subject property from General Industrial-Exception Five (GM-E5) to General Industrial-Exception Eight (GM-E8). The lands currently zoned Open Space (OS) are not affected. The lands are located within Part of Lot 22, Concession 5, and comprise an area of approximately 1.346 ha (3.33 acres) of land with the total land area.

Mayor Serviss asked to hear comments from the applicant. The applicant, Dr. Michelle Scantland, and Anthony Hommik of Jp2g Consultants Inc. came forward and provided some background information and rationale for the zoning by-law amendment request.

Mayor Serviss asked to hear comments from members of the public. Alex Riopelle commented on the amount of forest was planned to be removed and Terry Weinert commented on the planned property lighting. Anthony Hommik provided a reply to both questions, stating that the forest tree line would remain to the adjacent properties and that the lighting would only be on the building and parking area and not pointing towards adjacent properties. Jordon Kathnelson commented on what the Industrial Park plan looked liked for future business. Brent Pemberton spoke in support of the development.

Mayor Serviss asked to hear comments from members of Council. Ms. Cronier explained the 20-day appeal process.

Mayor Serviss declared the Public Meeting closed at 6:52 p.m.
