Public Meeting

1. Zoning By-law Amendment (from Residential Three (R3) to Residential One (R1) and Residential Three (R3) to Rural-Exception Nineteen (RU-E19), Part of Lot 3, Range B, in the Town of Petawawa

The Public Meeting was opened by the Mayor at 6:34 p.m. Melanie Scheer, Director of Planning and Development, introduced the zoning by-law amendment application for rezoning the subject lands as a condition of consent to separate the existing dwelling from the existing kennel to facilitate the sale of the kennel. Ms. Scheer advised that the Notice of the Public Meeting had been provided as required under the *Planning Act*.

Mayor Serviss asked if any written comments have been received regarding the application. Ms. Scheer confirmed that one written submission was received from Enbridge Gas Inc., of whom had no concerns regarding the application.

Ms. Scheer briefly explained the purpose of the amendment is to rezone the subject property from Residential Three (R3) to Residential One (R1) to recognize the existing dwelling and rezone the retained lands from Residential Three (R3) to Rural-Exception Nineteen (RU-E19) which contain the existing kennel and outbuildings.

Mayor Serviss asked to hear comments from the applicant. The applicant was not present, but Kathryn Curry, a Senior Planner from Jp2g Consultants Inc. was present to represent the applicant and answer any questions from the public.

Mayor Serviss asked to hear comments from members of the public. No comments were received from the public.

Mayor Serviss asked to hear comments from members of Council. Ms. Scheer explained the 20-day appeal process.

Mayor Serviss declared the Public Meeting closed at 6:37 p.m.
