CAO-05-2024 – Community Sport and Recreation Infrastructure Fund – Stream
New Builds

Scott Randolph, CAO, provided an overview of the report.

Members of Council discussed the grant application submission and the potential 2025 budget implications if the application request was successful.

Councillor Lisa Coutu put forth a motion that Council provide direction on submitting an application to the Community Sport and Recreation Infrastructre Fund (CSRIF) for \$425,398.00 and setting aside \$425,399.00 in matching funds for the 2025 financial year if it is approved. There was no seconder for the motion.

Direction was provided to staff to report back to Council on Recreation and Culture Reserves and budget commitments for 2025.
